School Services will begin on The Dandelions Montessori is open 10 months (September to June), following the academic school calendar, except for holidays, vacation, sickness and professional growth days listed in the Calendar. A summer session is offered in July.

The program is only offered as a 5-days/week option.

Hours:

- **FULL DAY:** 8:15 am to 3:00 pm
5 days per week: \$1,300.00/month for 10 months

- **HALF DAY:** 8:15 am to 12:30 pm
(Limited spaces available)
5 days per week: \$1,100.00/month for 10 months

AM: 7:45 am to 8-15 am (30 minutes): \$75/month

PM: 3:00 pm to 5:00 pm (2 hours): \$375/month

EC AM & PM (2.5 hours): \$415/month

Home School Rate:

- The tuition for school service is \$ _____ per month. Tuition must be paid in advance and can be paid by the 1st of each month. The Dandelions Montessori schoolhouse does NOT prorate months. The Dandelions Montessori reserves the right not to admit the child into the home school if payments are not received by the 15th of each month.
- Tuition can be paid in one annual payment or in monthly installments. There is a **2.5% discount** when the annual tuition is paid in full by September 1.
- Payment is accepted by cash, Venmo, check or direct deposit. Payment is due regardless of attendance.
- Returned checks must be paid by cash. Additional returned checks will result in cash or direct payment only. There will be a \$25 returned check charge plus any additional charges incurred to The Dandelions Montessori and/or by the bank.

Fees due upon enrollment:

- Registration fee (yearly): \$250.
- Material Fee (yearly): \$250 (waived the third year)

Sibling Discounts

- There is a 5% discount for the second child in a household enrolled concurrently and for all additional siblings. The discount will be taken off the lesser rate of the siblings (the discount applies to the monthly tuition only, not applicable to the other fees)

Other charges:

- Due to cost of living increases, all home school fees are subject to change from one school year to the next. A 30-day advance notice will be given prior to any rate change.

Nutrition

The home school service will include the following meals and snacks:

Breakfast AM Snack Lunch

Families and School provider will work together to offer high quality food to the children. Each family must choose one of the following lunch options:

Option 1: your child brings a lunchbox

Option 2: the school provides meals. Children participate in school cooking activities. Parents bring a selection of ingredients on each Monday.

Release of Child:

Children may be taken from The Dandelions Montessori home school only by the person/s signed below and those named on the Authorization to Leave Care form.

2-Week Trial Period (new families enrolled)

A trial period of The Dandelions Montessori schoolhouse service will begin on _____ (insert date). During this time, either the client or the provider may cancel the contract immediately, without written notice. If the contract is cancelled during this ***2-week*** trial period, the client will pay a prorated fee.

Termination Procedure:

The Client may terminate this contract at any time with 30 days written and paid notice. The provider may provide 30 days written notice of termination but reserves the right to immediate termination if the client or child poses any threat to the safety and welfare of the other children in the schoolhouse, the provider's family or failure to comply with policies.

All parties agree to the contract terms and understand this is a binding agreement. By signing this contract, clients indicate that they have read the provider's policies and agree to follow them. I reserve the right to make changes to my policies without notice. This contract is entered into by the client and provider and will remain in effect until termination of service or the signing of a new contract.
